

**THE CITY OF ALBION, IDAHO
RESOLUTION NO. 2015-03**

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF ALBION, IDAHO, INCREASING RESIDENTIAL AND COMMERCIAL SEWER MONTHLY RATES BY FIFTEEN DOLLARS EACH SERVICE PER MONTH, EFFECTIVE APRIL 15, 2015.

WHEREAS, the Mayor and City Council have studied rates relative to obtaining grant funding and for providing for ongoing maintenance of city sewer infrastructure; and

WHEREAS, the Mayor and City Council have determined that it is reasonable and necessary to raise both residential and commercial sewer rates to adequately repair and maintain the city sewer system; and

WHEREAS, public hearing was held on proposed increases of fifteen dollars (\$15.00) each service per month for both residential and commercial sewer services, said hearing being held on April 7, 2015; and

WHEREAS, the Mayor and City Council heard public testimony, the general tenor of which was, that the increase needed to occur; and

WHEREAS, the Mayor and City Council have determined that it is reasonable and appropriate to raise Customer's residential and commercial sewer service rates, which are currently Thirty Dollars (\$30.00) for residential and ~~Fifty Dollars (\$50.00)~~ ^{Forty-five (\$45.00)} for commercial, to Forty-Five Dollars (\$45.00) and Sixty-Five Dollars (\$65.00) respectively, to offset part of the costs to the City for maintaining and upgrading the city sewer system.


NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Albion that the "per service" rate for city sewer services shall be increased from Thirty Dollars (\$30.00) to Forty-Five Dollars (\$45.00) for monthly residential sewer

service and increased from Fifty Dollars (\$50.00) to Sixty-Five Dollars (\$65.00) for monthly commercial sewer service.

BE IT ALSO RESOLVED by the Mayor and City Council of the City of Albion that said increase shall be in effect from and after April 15, 2015.

The foregoing resolution was passed and approved at a duly noticed public meeting of the Albion City Council, held in compliance with the Open Meeting Law of the State of Idaho on the 5th day of May, 2015, by a vote of 4 in favor and 0 opposed to said resolution. This written resolution memorializes said action, being executed *Nunc Pro Tunc* this 2nd day of June, 2015 for the 7th day of April, 2015.
